- (iii) At least 2-3 Salary slips per year (including start and end of the year) along with additional pay slips (for variable/special payments) covering experience claimed.
- (iv) Form 16 & ITR in support of the emoluments

In case of experience in Govt./ Semi-Govt./ PSU/ Autonomous bodies/ Co-operative establishments, candidates are advised to attach copy of their online applications through proper channel with NOC or produce NOC from present employer at the time of interview. The decision of NSPCL shall be final and binding in this regard. Such candidates are required to provide all supportive details in respect of their eligibility along with the application.

Eligible candidates will have to appear for All India based Online Selection Test. The online selection test will have two parts i.e Subject Knowledge Test (SKT) & Executive Aptitude Test (EAT). The candidates are required to qualify both in Subject Knowledge Test (SKT) and Executive Aptitude Test (EAT), separately. Based on merit and requirement of the post; candidates will be short listed for Personal Interview. All shortlisted candidates after written test will have to secure minimum qualifying marks in Interview, as applicable. The final selection will be on the basis of 85% weightage of online selection test and 15% weightage of interview marks.

Candidates have to choose any two cities as preference-I and preference-II, as Test Centre and no change in any circumstance will be considered subsequently. However, NSPCL reserves the right to cancel or add any centre depending on the response of the candidates for that area / centre.

RESERVATIONS / RELAXATIONS / CONCESSIONS:

1. Reservations, relaxations and concessions for SC/ST/OBC (non-creamy layer)/XSM /PwBD (degree of disability 40% or above) candidates will be provided as per Government guidelines.
2. Candidates claiming to belong to any particular category shall necessarily have a valid EWS/SC/ST/Disability certificate/OBC (Non- Creamy Layer) as the case may be, from the competent authority (in the latest prescribed format of Govt. of India).
3. Category once filled in the online application form will not be changed and no benefit of other category will be admissible later on.
4. Where there is a vacancy identified for such category, upper age limit is relaxed by 5 years for SC/ST candidates, by 3 years for OBC candidates & by 10 years for PwBD candidates. Relaxation of age to Ex-Serviceman will be as per Govt. guidelines.

Selected candidates will be placed in the initial basic pay of respective pay scale. The other benefits such as Dearness Allowance, other perquisites, allowances, terminal benefits, etc. will be admissible as per company rules in force from time to time.

The selected candidates who belong to General category will be required to execute a service agreement bond of Rs. 5,00,000/- (Rs. 2,50,000/- for candidates belonging to SC, ST, PwBD categories) to serve NSPCL for at least 4 years after joining the company.

The candidate should have sound health. Before joining, candidates will have to undergo medical examination at any of the NSPCL notified/ empanelled/project hospitals and the decision of NSPCL will be final and binding. 1. Only Indian Nationals are eligible to apply.
2. All qualifications should be from Universities / Institutions recognized and approved in India. SC/ST/PwBD candidates with passing marks in the qualifying degree are also eligible to apply for the post.
3. All computations of age/ experience requirement / qualification etc. shall be done w.r.t. the last date of receipt of online application as mentioned in the advertisement.
4. Depending on the requirement, the Company reserves the right to cancel / restrict / curtail / increase the number of vacancies, if need arises, without any further notice and without assigning any reason thereof.
5.
